Cost includes transportation and lift ticket, but does not include rentals or lessons with the exception of the Bretton Woods trip.

Equipment rentals differ mountain to mountain (\$28-\$50). A separate payment and liability waiver will be required if your teen needs to rent equipment.

***NIGHT TRIPS:** We normally leave around 3:00pm and return to the club by 9/9:15pm. This gives the teens about 3 hours on the mountain. Our homework room is open at 2:15pm and Ski & Ride Club members are encouraged to work on their homework at this time. Ski & Snowboard gear can be dropped off at the club the afternoon before or anytime the day of the trip. We have a secure storage closet.

**** Additional trips may be offered in February/March. No deposit required at this time. More information will be available early 2012.**

ADDITIONAL COSTS (if needed)

It is up to the teen to bring the extra money for these additional costs

Food: Food is available at the mountain. However, we recommend that you bring food with you, since food sold at mountains is known to be pricey. Also, depending on behavior and other circumstance, we will also plan to make a stop at Burger King, Wendy's or some place of the like on the way home. Please plan accordingly.

***Rentals:** If renting, please fill out the "Rental Waiver and Agreement" form for each designated trip. These forms need to be completed and passed in before the schedule trip.

REQUIREMENTS

- ❖ The "Emergency Waiver" and "Ski Club Rules" sheet must be signed and returned BEFORE you attend these trips.
- ❖ **You must be an active member** of the Eclipse Teen Center and have an Eclipse Teen Center ID card in order to participate in this program. This ID card also should be brought with the teen each time he/she goes on a trip. (Please see an Eclipse Teen Center staff member if you have any questions) (Non-members may sign-up for Bretton Woods trip for \$55)

DUE DATES

- ❖ Full-payment for trips must be made two weeks prior to trip or spot may be released to a child on the wait-list. **You can reserve a spot on each trip by placing a NON-REFUNDABLE deposit of \$20 per trip.** The deposit may be transferred to another trip if requested two weeks prior to initial trip.
- ❖ A **refund** may be granted if we are given at least two weeks notice, or if a trip is cancelled due to weather. Please keep in mind we will be purchasing some tickets in-advance that are non-refundable to us (which means non-refundable to participants also).
- ❖ Checks can be written to "SalemBGC" ; **Payments can also be made on our website.**

REMEMBER: all trips are on a first come first served basis!

Ski & Ride Club Rules

1. Proper behavior is expected at all times!
2. A permission slip and waiver must be signed before attending trips.
3. Teens must obey the “rules of the mountain,” any skier/rider codes provided by the resort and the rules of the Eclipse Teen Center and its staff at all times!
4. Absolutely no horseplay or fooling around in van or bus.
5. Proper attire must be worn at all times on the slopes!
6. Teens must be on-time to ALL SKI CLUB MEETING TIMES and CHECKPOINTS. Any teens late when departing the ski area will lose privileges for next trip and possible suspension from ski club!
7. Teens must ski/ride in groups of 2 or more OR with a staff member at all times.
8. No leaving ski area boundaries!
9. If rentals are needed, you must bring in completed rental forms and rental payment the night you are attending ski club. Failure to do so will prohibit you from attending that ski club trip.
10. The Ski & Ride Club will leave Boys & Girls Club by the designated departure time. Participants who miss the departure time will not be refunded.
Teens are asked to inform the staff if they will be absent from the trip.

Failure to follow these rules, may result in suspension from “Ski and Ride Club” and possibly the Eclipse Teen Center. *
